That the Defendant, on 06/07/2025 at 428 Balltown Rd, in the Town of Niskayuna, Schenectady County, New York, did commit the offense of Petit Larceny, a misdemeanor in violation of section 155.25 of the Penal Law of the State of New York, in that (s)he did, at the aforesaid time and place.

COUNT ONE: A person is guilty of petit larceny when he steals property.

THE FACTS UPON WHICH THIS INFORMATION IS BASED ARE AS FOLLOWS:

That on the above date and location, at approximately 1750 hours the Defendant did attempt to steal multiple pieces of Women's clothing, Groceries, and Pet food. The approximate value of said property being \$180.60.

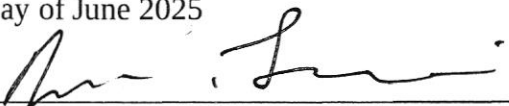
All this being contrary to and in direct violation of the above section of law.

At approximately 5:50 PM, I detained the subject and recovered the concealed clothing merchandise as well as other unpaid merchandise. Target will be filing charges for the unpaid merchandise.

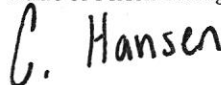
